


End of Year Certificate (EOYC) update

Electronic letter submissions

Monthly Data Collection (MDC) submissions

When completing your April MDC file, please remember that for Annual Allowance purposes, HMRC requires that service be split with one line covering 1-5 April, and the next covering 6-30 April.

If you haven't split the lines, you'll receive an email explaining that there's an error with your file for each incorrect line and how you should correct it.

McCloud update

Following on from last month's update, we want to remind you that the Government will be publishing their detailed proposals later this year, which will form a public consultation. This will provide you with the opportunity to provide your feedback on the proposals. We'll advise you of the dates of the consultation as soon as we have them.

The key message to provide to your employees is that their pension entitlements are safe, and the Government changes will apply to all affected members of the Scheme, and not just for those who make a claim.
