
We'd like to remind you to ensure that you return your MDC submission on or before the 7th of each month, or on the last working day prior to this if it's a nonworking day.

Update on McCloud case

We've previously informed you of the outcome of the legal case brought by members of the Judicial and Firefighters' pensions schemes, which found that transitional protection arrangements were discriminatory. The ruling will also apply to all main public service schemes, including the Teachers' Pension Scheme.

It's too early at this stage to speculate the outcome of the developing changes to pension schemes; however, the Government has committed to ensure every member is treated equally and keep benefits that they have already accrued.

There are different reasons why these errors will occur; an incorrect format in the data, the data item doesn't match the expected value, or a mandatory value is missing. Opposite sex (mixed sex) civil partnerships

Following the introduction of opposite sex civil partnerships in England and Wales from 31 December 2019, there've been recent changes made to the Teachers' Pensions Regulations (TPR) in relation to survivor benefits.

An opposite sex civil partner will now qualify for survivor benefits and will be aligned to those available to the spouse of a member who was in an opposite sex marriage.
